JLPOA news:

When lot dues are in arrears, as of the third month late in payment a lien will be filed against the property by the JLPOA.

All construction and/or lot improvements must be approved by the JLPOA Architectural Committee before submittal to Morgan County – contact Mary Peska (970-370-8793)

Clubhouse rental - \$50/\$75 with kitchen + \$50 refundable deposit/requires clubhouse rental agreement available from a board member or online

Guest passes are required for all non resident guests

Make sure that your lot owner contact information is up to date in JLPOA files

Lot identification #s should be attached to all summer water hookups with a backflow device in place

Lot identification numbers must be on all golf carts/atv's/any unlicensed vehicle – lights are required for driving after dark ***Violators of these policies will be given a first warning to comply. A second warning will carry a \$25 fine against the lot owner of the vehicle. A third violation will mean the vehicle is banned from the JLPOA roads.

Septic warning system must be in place – manual or electronic

Dumpster rules – no trash from outside the park / no hazardous waste, furniture, appliances, or construction/demolition waste
