  - 5.11 Flood prevention and drainage Glenn is working on his as property owner. Everyone is ok with it.
  - 5.12 Inlet Tumbleweeds/Low water Maintenance Needs. Keith is still waiting for parts. Larry Flemming offered to try to put his pontoon in to try to loosen stuff, if that doesn't work, we will probably have to wait until spring.
